

Terms of Sale:

All properties are sold "AS IS, WHERE IS" with no contingencies to financing, inspections or any other type of contingency. Please do not bid if you have not inspected the property personally to your satisfaction. The Auction Group LLC represents the seller's only and does not inspect properties on Bidder's behalf.

DO NOT BID until you have registered, received a bidder's card and sale day notes, and agree to be bound by the terms of sale in the contract as they are final upon you becoming a bidder. Your registration at the auction finalizes your agreement to the terms and conditions of the sale as stated in the contract and its addenda.

Each high bidder must make a 10% or \$5000 minimum non-refundable deposit immediately after the auction. Cash, cashiers check and personal checks are accepted. The balance of the purchase price and all closing costs are due within 30 days. Closing costs typically include the title exam, title policy, closing fees, filing costs, and usually total \$1,500 or more. Buyers receive a Deed and Title Insurance Policy as provided by the closer indicated on the contract. Current year's taxes are prorated through the day of closing. Any mobile/manufactured housing will be sold on a bill of sale.

A "Rapid Close" option may be available. This will be announced day of sale and/or listed in the disclosure. If offered, the seller will pay all of the closing costs if the buyer pays in full the purchase price and any other non-title fees day of the sale.

Inspect properties and/or attend the auctions at your own risk. Broker and seller, their agents, and employees shall not be liable to any person for damages to their person or property while in, on or about these properties. Further, the broker, seller, their agents, and employees shall not be liable for hidden defects, dangers or conditions.
